RESOLUTION No._____/R/ELECAM/CE OF _____ Relating to the rejection of lists of candidates for the election of Senators scheduled for 25 March 2018

THE ELECTORAL BOARD,

Meeting in session as of right on 7 March 2018 in Yaounde,

Mindful of the Constitution;

Mindful of Law No.2012/001 of 19 April 2012 relating to the Electoral Code, amended and supplemented by Law No.2012/017 of 21 December 2012;

Mindful of Decree No.2010/319 of 13 October 2010 to determine the effective putting in place of Elections Cameroon;

Mindful of Decree No.2015/322 of 21 July 2015 renewing the term of office of certain Members of the Electoral Board of Elections Cameroon (ELECAM);

Mindful of Decree No.2016/203 of 20 April 2016 appointing a Member of the Electoral Board of Elections Cameroon (ELECAM);

Mindful of Decree No.2016/204 of 20 April 2016 appointing a Member of the Electoral Board of Elections Cameroon (ELECAM);

Mindful of Decree No.2017/167 of 25 April 2017 renewing the term of office of certain Members of the Electoral Board of Elections Cameroon (ELECAM);

Mindful of Decree No.2017/168 of 25 April 2017 appointing Members of the Electoral Board of Elections Cameroon (ELECAM);

Mindful of Decree No.2017/168 of 25 April 2017 appointing Members of the Electoral Board of Elections Cameroon (ELECAM);

Mindful of Decree No.2017/169 of 25 April 2017 appointing the Chairperson and the Vice-Chairperson of the Electoral Board of Elections Cameroon (ELECAM);

Mindful of Decree N° 2018/103 du 07 February 2018 convening the electoral college for the election of Senators;

Following deliberations,

ADOPTED THE RESOLUTION SET OUT AS FOLLOWS:

Section 1:- After a thorough scrutiny of the nomination papers contained in forty-two (42) lists of candidates submitted by nine (9) political parties for the election of Senators scheduled for 25 March 2018, five (5) lists of candidates found not in fulfilment with the conditions required by law were disqualified and rejected unanimously by the Members of Electoral Board present.

The Electoral Board hereby took note of the withdrawal "Social Democratic Front

(SDF)" to withdraw its list of candidates in the Centre Region.

Section 2:- The following lists of candidates are hereby rejected per region:

I- ADAMAWA REGION

<u>UNION DES POPULATIONS DU CAMEROUN (UPC)</u>

Reasons:

- ➤ Incomplete list of alternate candidates: 2 names out of 7;
- Absence of signature on the declarations on honour of the candidates;
- ➤ Absence of the certificate of non-conviction (Bulletin No.3) for the candidate, LONGA DJANGAL Jean;
- > Two (2) birth certificates for the substantive candidate, IBRAHIMA;
- ➤ Absence of the certificate of payment of deposit for all the candidates;
- Absence of a copy of the birth certificate for two (2) alternate candidates.

II- EAST REGION

SOCIAL DEMOCRATIC FRONT (SDF)

Reasons: All the nomination papers submitted are incomplete:

- ➤ Absence of originals of the payment of deposit;
- ➤ Absence of a copy of the birth certificate for the substantive candidate, FENYITE MOUTCHEGUE HENRIETTE

III- FAR NORTH REGION

SOCIAL DEMOCRATIC FRONT (SDF)

Reasons:

- ➤ Nomination papers legalised without signatures;
- ➤ Incomplete list of the alternate candidates.

IV- NORTH REGION

UNION DES POPULATIONS DU CAMEROUN (UPC)

Reasons:

- > Incomplete nomination papers for the alternate candidates: **MOHAMADOU** DALIL, KOULTCHOUMI. ALPHA **BADJAM** MOKOLO, TCHINDEBE MOISE, IBRAHIM KODOUE MANGA (absence of a copy of the birth certificate – certificate of non-conviction (Bulletin No.3), the certificate of residence, the certificate of nationality ...);
- ➤ Absence of the certificate of payment of deposit for all the candidates.

V- SOUTH-WEST REGION

UNION DES POPULATIONS DU CAMEROUN (UPC)

Reasons:

- Absence of nomination papers for all the alternate candidates;
- Absence of the certificate of non-conviction (Bulletin No.3), absence of the tax certificate and the certificate of payment of deposit for all the substantive candidates:
- ➤ One (1) single candidate out of the seven (7) substantives attached a nomination paper.
