Following deliberations,

ADOPTED THE RESOLUTION SET OUT AS FOLLOWS:

Section 1: After a thorough scrutiny of the nomination papers 42 (forty-two) political parties for the election of Municipal Councillors set for 9 February 2020, 56 (fifty-election six) lists of candidates found not in fulfilment with the conditions required by law were rejected in unanimity by the Members of Electoral Board.

The following lists of candidates are hereby rejected per electoral constituency and per political party:
