



RESOLUTION No. 018 /ELECAM/CE OF 09 DEC 2019,
relating to the rejection of lists of candidates for the election
of Members of Parliament set for 9 February 2020

THE ELECTORAL BOARD,

Meeting in session as of right on the 9th of December 2019 in Yaounde,

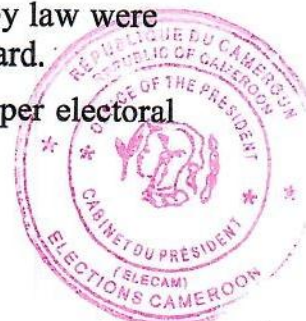
- Mindful of the Constitution;
- Mindful of Law No.2012/001 of 19 April 2012 relating to the Electoral Code, amended and supplemented by Law No.2012/017 of 21 December 2012;
- Mindful of Decree No.2010/319 of 13 October 2010 to determine the effective putting in place of Elections Cameroon;
- Mindful of Decree No.2016/203 of 20 April 2016 appointing a Member of the Electoral Board of Elections Cameroon (ELECAM);
- Mindful of Decree No.2017/167 of 25 April 2017 renewing the term of office of certain Members of the Electoral Board of Elections Cameroon (ELECAM);
- Mindful of Decree No.2017/168 of 25 April 2017 appointing Members of the Electoral Board of Elections Cameroon (ELECAM);
- Mindful of Decree No.2017/169 of 25 April 2017 appointing the Chairperson and the Vice-Chairperson of the Electoral Board of Elections Cameroon (ELECAM);
- Mindful of Decree No.2019/475 of 16 September 2019 renewing the term of office of certain Members of the Electoral Board of Elections Cameroon (ELECAM);
- Mindful of Decree No.2019/476 of 16 September 2019 appointing a Member of the Electoral Board of Elections Cameroon (ELECAM);
- Mindful of Decree No.2019/612 of 10 November 2019 to convene the electorate for the election of Members of Parliament and Municipal Councillors;
- Mindful of Decision No.012/D/ELECAM/CAB of 28 November 2019 to set up and lay down the organisation and functioning of the commission for scrutiny and validation of candidacies for the legislative and municipal elections of 9 February 2020.

Following deliberations,

ADOPTED THE RESOLUTION SET OUT AS FOLLOWS:

Section1.- After a thorough scrutiny of the nomination papers submitted by 35 (thirty-five) political parties for the election of Members of Parliament set for 9 February 2019, 16 (sixteen) lists of candidates found not in fulfilment with the conditions required by law were rejected in unanimity by the Members of Electoral Board.

The following lists of candidates are hereby rejected per electoral constituency and per political party:



➤ **ADAMAWA REGION**

: **Electoral constituency** MBERE

Political party: UPC

Reasons:

- Two different lists submitted for the same election.
- No payment of deposit.

➤ **CENTRE REGION**

Electoral constituency: LEKIE OUEST

Political party: PADDEC

Reasons:

- Incomplete list: a single nomination paper for the 3 (three) seats to be filled.

Electoral constituency: MEFOU ET AFAMBA

Political party: PADY

Reasons:

- No tax certificate or tax exemption certificate;
- No attestation of registration on an electoral register;
- No payment of deposit.

Political party: UCDI

Reasons:

- No payment of deposit.

Electoral constituency: MFOUNDI

Political party: UPC

Reasons:

- Two different lists submitted for the same election;

Electoral constituency: NYONG ET KELLE

Political party: UPC

Reasons:

- Two different lists submitted for the same election.

- Two different lists submitted for the same election.

Electoral constituency: MOUNGO SUD

Political party: PADDEC

Reasons:

- Non-payment of the deposit by all candidates on the list;
- No tax certificate or tax exemption certificate.

Electoral constituency: SANAGA MARITIME

Political party: UPC

Reasons:

- Two different lists submitted for the same election.

Electoral constituency: WOURI – EST

Political party: PCRN

Reasons:

- Non-payment of the deposit by all candidates on the list;

Political party : UPC

Reasons:

- Two different lists submitted for the same election;

Electoral constituency: WOURI – OUEST

Political party : UDT

Reasons:

- No payment of the deposit;

Electoral constituency: WOURI – SUD

Political party: UPC

Reasons:

- Two different lists submitted for the same election.

- **WEST REGION**



Electoral constituency: MENOUA

Political party: RDPF KUMZSE

Reasons:

- Incomplete list: a single candidate out of the five seats to be filled.

(see *Section 153 of the Electoral Code*)

Electoral constituency: MIFI

Political party: PADDEC

Reasons:

- Declaration on honour not legalised for all the candidates;
- No tax certificate or tax exemption certificate;
- No payment of deposit for all the candidates.

(See *Sections 164, 165 and 166*)

Electoral constituency: MIFI

Political party : UDC

Reasons:

Absence of:

- Tax certificate or non-tax certificate for all the candidates,
- Payment of deposit for all the candidates;
- Attestation of registration on electoral registers for the three candidates.

(see *Sections 164-1 and 4, 165 and 166*)
